This draft report contains an outline of federal, state, and local policies related to grape and wine production. For the Virginia grape site assessment and prioritization being developed by Virginia Tech CGIT for the VWB, this review is being conducted to identify policies with a spatial component that can be operationalized in the site assessment model and report at http://www.cgit.vt.edu/vineyards. For example, we have identified GIS layers for: Ag and Forest Districts, land and historic conservation easements, endangered species, etc.

Furthermore, policy and regulatory aspects of the industry can be challenging for new producers. This collection serves as a new resource that provides an overview of key policies and regulations in a single document, and may serve as a basis for further use by the Virginia Wine Board and its stakeholders, as well as economic developers and policymakers. Once the outline is completed, an introduction and brief description of each item may be included as time allows. Upon satisfactory completion of this resource, we suggest that the final version could be distributed as a package along with the statewide land assessment and prioritization resources. It is anticipated that the statewide site assessment should generate substantial interest across Virginia in establishment of new vineyards.
